### **REQUIREMENTS FOR APPOINTMENT**

### SENIOR LECTURER – GRADE THIRTEEN (13)

#### **Requirements for Appointment:**

To be eligible for appointment and/or promotion to the position of Senior Lecturer the candidate must have:

(i) a Doctorate degree (Ph.D) or its academic equivalent from an accredited/recognized institution;

OR

MMed or MDS, and Specialist training;

- (ii) a cumulative or evidence of three (3) years of teaching/research experience at University level since becoming Lecturer/Research Fellow;
- (iii) research output points comprising at least twenty four (24) points from refereed scholarly journals, six (6) points from postgraduate students' supervision and two (2) points from publications in conference proceedings since appointment to the position of Lecturer;
- (iv) evidence of having developed proposals that have attracted funding to the University;
- (v) attended and contributed at learned conferences, seminars or workshops;
- (vi) evidence of continued evaluated effective teaching and research;
- evidence of contribution to University service through active participation in Departmental matters, students' academic, and School and University meetings and committee membership, among others;
- (viii) evidence of recognition and registration by the relevant regulatory bodies where applicable; and
- (ix) evidence of membership or affiliation to the relevant professional body where applicable.

# LECTURER – GRADE TWELVE (12)

### **Requirements for Appointment:**

To be eligible for appointment to the position of Lecturer, the candidate must have:

A doctorate degree (Ph.D) from an accredited/recognized institution;
OR

MMed or MDS, and Specialist training;

 (ii) A minimum of twelve (12) research publication output points from refereed scholarly journals and two (2) points from publications in conference proceedings,

OR

A minimum of thirty-two (32) publication points if the applicant is from a research institution,

OR

A minimum of six (6) publication points if the applicant is from practice/industry.

- (iii) evidence of recognition and registration by the relevant regulatory body where applicable; and
- (iv) evidence of membership or affiliation of the relevant professional body where applicable.

# TUTORIAL FELLOW - GRADE ELEVEN (11)

### **Requirements for Appointment**

To be eligible for appointment to the position of Tutorial Fellow, the candidate must have:

(i) a Bachelor's degree and a Master's degree from an accredited/ recognized University: OR

MBChB or BDS;

- (ii) demonstrable potential for university teaching and or research during the appointment interview and also during the contract period;
- (iii) registered for a relevant Doctorate (Ph.D.) degree or MDS or MMed;

- (iv) evidence of membership or affiliation to the relevant professional body where applicable;
- (v) Proficiency in computer applications;
- (vi) Demonstrated merit and ability as reflected in work performance;

# **SENIOR LEGAL OFFICER - GRADE THIRTEEN (13)**

### **Requirements for Appointment**

For appointment to this grade, a candidate must have:

- i. Bachelor's Degree in Law from a recognized and accredited institution
- ii. Masters Degree in Law from a recognized and accredited institution;
- iii. Postgraduate Diploma in Law from Kenya School of Law;
- Admitted as an Advocate of the High Court of Kenya with a valid practicing certificate;
- v. Registered as a member of the Law Society of Kenya in good standing;
- vi. Demonstrate a clear understanding of national development policies, goals, objectives and ability to integrate them in legal functions;
- vii. Certificate in leadership course lasting not less than four (4) weeks from a recognized and accredited institution;
- viii. Proficiency in computer applications;

# **DEPUTY CHIEF SECURITY OFFICER - GRADE TWELVE (12)**

### **Requirements for Appointment**

For appointment to this grade, a candidate must have:

i. Attained rank of Chief Inspector of Police;

#### OR

ii. Masters in relevant field from a recognized and accredited institution;

- Bachelor's Degree in the relevant field from recognized and accredited institution;
- iv. Relevant technical and professional certification from recognized and accredited institution;
- v. Registered with relevant professional body (where applicable);
- vi. Certificate of clean record of discharge from the relevant disciplined service (where applicable);
- vii. Proficiency in computer applications;
- viii. Demonstrated merit and ability as reflected in work performance and results;
- ix. Certificate in leadership course lasting not less than four (4) weeks from a recognized and accredited institution;

# CLERK OF WORKS - GRADE NINE (9)

For appointment to this grade, a candidate must have:

- i. Bachelor's Degree in Engineering, Building Technology, Architecture or relevant field from a recognized and accredited institution;
- ii. At least three (3) years relevant work experience in a comparable position
- iii. Proficiency in computer applications;
- iv. Relevant technical and professional certification from recognized and accredited institution;
- v. Registered with relevant professional body (where applicable);
- vi. Demonstrated merit and ability as reflected in work performance and results.

# ICT OFFICER I (SOFTWARE DEVELOPER) - GRADE TEN (10)

To be eligible for appointment to the position of Software Developer, the candidate must have:

- i. Bachelor's degree in computer science or related field;
- ii. Proficiency with server-side languages such as Python, Java, or .Net, and utilizing external APIs for integration with partner systems;
- iii. Proficiency with fundamental front-end languages such as HTML, CSS, and JavaScript and frameworks such as NextJS, React or VueJS;
- iv. Proficiency in developing simple mobile applications for Android and iOS is a plus;
- v. Understanding of software quality assurance processes and a demonstrated ability to self-test and personally ensure the quality of the code;
- vi. Direct experience with relational database technology such as MySQL, PostgreSQL, RDS, etc;
- vii. Direct experience with non-relational database technologies such as MongoDB, DynamoDB, etc;
- viii. Experience with AWS infrastructure or other similar cloud-based infrastructure services;
- ix. Knowledge of SCRUM agile software development;
- x. Experience working with REST and/or GraphQL APIs.

# ICT OFFICER I (WEB DEVELOPER) - GRADE TEN (10)

To be eligible for appointment to the position of Web Developer, the candidate must have:

- i. Bachelor's degree in computer science or related discipline
- ii. Strong verbal and written communication skills for effectively conveying technical concepts to both technical and nontechnical stakeholders.
- iii. Proven experience in building, deploying, and maintaining web applications using modern frameworks such as Node.js and React.js.
- iv. Strong proficiency in JavaScript, HTML5, CSS3, and responsive design principles.

- v. Experience with shell scripting or other scripting languages for automating repetitive tasks.
- vi. Hands on experience with AWS (e.g., EC2, S3, RDS, IAM) or equivalent cloud platforms.
- vii. Familiarity with Kubernetes or containerization tools for deploying scalable applications.
- viii. Proficiency in relational databases (e.g., PostgreSQL) and graph databases (e.g., Neo4j).
- ix. Knowledge of DevOps practices, including version control (Git), and experience in optimizing deployment workflows for reliability and performance.

# LABORATORY TECHNICIAN II (NUTRITION) - GRADE FIVE (5)

### **Requirements for Appointment**

To be appointed as Technician II (Nutrition) one must have the following;

- i. Diploma in the relevant field from recognized institution.
- ii. Four (4) years relevant experience.
- iii. Demonstrable Information Communication Technology skills from a recognized institution.
- iv. Demonstrated ability in handling laboratory services.

### LABORATORY TECHNOLOGIST (PUBLIC HEALTH) GRADE 9

For appointment to this grade, a candidate must have: -

- i. Bachelor's degree in any of the following disciplines: Public Health or equivalent qualification from a recognized and accredited institution.
- ii. Registered with relevant professional body;
- iii. Valid practicing license from the relevant professional body;and
- iv. Proficiency in computer applications.
